§ 5.1 Civil Service regulations. The Director, Office of Personnel Management , shall promulgate and enforce regulations necessary to carry out the provisions of the Civil Service Act and the Veterans' Preference Act, as reenacted in title 5, United States Code, the Civil Service Rules, and all other statutes and Executive orders imposing responsibilities on the Office.

Philadelphia Civil Service Regulations

Whenever an appointing authority requires the temporary employment of a person who does not have permanent Civil Service status to fill a position for a limited period not to exceed six (6) months, he/she shall so advise the Director, stating the duration of such period, and the duties to be performed.

Michigan Civil Service Commission Regulation 5

The Civil Service Regulations are administrative regulations made by or with the authority of the Chief Executive. They set out the authority of the Secretary for the Civil Service and Heads of Department/Grade on day-to-day management of the Civil Service, the terms of appointment and conditions of service for public servants, as well as the standards of conduct and performance expected of them.

Civil Service Bureau - Overview

All other provisions of Regulation 21 shall apply to employees who are appointed to a Civil Service position immediately after termination of employment with the First Judicial District. 21.036 - OVERTIME OR COMPENSATORY TIME.
