History of Property Taxes in the United States. Glenn W. Fisher, Wichita State University (Emeritus) Taxes based on ownership of property were used in ancient times, but the modern tax has roots in feudal obligations owned to British and European kings or landlords.

History of Property Taxes in the United States

Personal property: Chattels. The term chattel sometimes refers to all kinds of personal property, but often it refers only to tangible personal property (such as nose flutes and toenail clippers) as opposed to intangible property.. A chattel, such as a furnace, can be affixed to land and become part of the real property. Such chattels are called fixtures.

The Representation of the People Act 1832, known as the first Reform Act or Great Reform Act: disenfranchised 56 boroughs in England and Wales and reduced another 31 to only one MP; created 67 new constituencies; broadened the franchise's property qualification in the counties, to include small landowners, tenant farmers, and shopkeepers
